I. 《費用》

1. 潛水會、潛水中心/商業登記證 - 會費為 HK\$1000
2. 社團/ 非牟利團體/學校/青年中心 - 會費為 HK\$200。
3. 潛水機構 - 會費為 HK\$1,000。
4. 贊助商 - 會費為 HK\$1,000。
5. 中國香港潛水總會有權調整費用，而作為會員，須同意總會之收費調整。
6. 如擁有個人會員三十位以上在潛總會藉登記，來年續會費用，則獲全免。

I 《Fees》

1. Dive Club, Dive Centre / Business Registration Certificate - annual fee is HK\$1000.
2. Society/ Non-profit-organisation, School or Youth Center - annual fee is HK\$200.
3. Diving Corporation - annual fee is HK\$1,000.
4. Sponsor - annual fee is HK\$1,000.
5. HKCUA has the right to increase the fees from time to time at their sole discretion, and by continuing to be a member of the HKCUA, you must agree the increased fee adjustment.
6. For having over 30 individual members registered under HKCUA membership, renewal fee will be waived in next renewal year.

II 《入會手續》

1. 申請會籍之團體初步需遞交以下文件：

 - a- 水肺潛水 - 8 名註冊/認可潛水員及 2 位註冊/認可潛水教練
 - b- 水下運動 - 8 名註冊/認可蹼泳員 (其中 2 位需為註冊蹼泳運動員) 及 2 位註冊/認可蹼泳教練 (其中一位需為二級或以上)

在審批完上列初步申請文件後，若無特別問題，本會會派人告知申請人提交相關財務資料、發展策略的報告及其他文件，以呈會籍委員會作正式評審。

2. 會籍有效期至翌年三月三十一日止，團體可由一月起辦理延續翌年會籍手續，所有團體會員必須簽署表格內之聲明書方為有效。
3. 新加入團體會員之會籍以一年為監察期，根據其表現於來年評核後再決定是否接受其更新會籍之申請資格。
4. 延續會籍之團體只需填妥延續會籍表格及簽名，連同有效登記證明及所需會費一起遞交；如有任何更新，可於表格內填寫。
5. 中國香港潛水總會有限公司保留對有關申請的最終批核權。

II 《Entry Procedures》

1. Submit following documents for application:
 - i- Completed *M-001A Application Form together with application fee.
 - ii- Valid copy of Business Registration Certificate and Certificate Of Incorporation/Certificate of Non-Profit Making Organization / Certificate of Charitable Organization.
 - iii- HKID card copy of club representative person.
 - iv- Not less than 10 registered/recognized individual Full members
 - a) Diving section: Not less than – 8 registered/recognized divers AND Not less than 2 registered/recognized diving instructors.
 - b) Sports section: Not less than – 8 registered/recognized Finswimmer (2 of them must be registered Finswimming athletes) AND Not less than 2 registered/recognized Finswimming instructors, one of them must be Level II Finswimming instructor.
2. Memberships are valid until 31st March every next year. Renewal procedure can be started on January. All Corporate membership is valid only when the declaration is duly signed.
3. The first year is the probation period for new member. Renewal is subject to the performance of the member under assessment review.
4. Renewal member only needs to complete renew application form together with renewal fee and valid copy of certificate; complete and amend items in the application forms for updating/ changing information.
5. HKCUA reserves the right to the application approval.

III 《權利義務及優惠條款》

1. 所有團體會員必需遵守總會所制定之守則。
2. 所有團體會員應最遲於同年四至六月底前完成延續會籍手續，否則其權利將於翌年四月一日起暫停。
3. 所有團體會員如會籍超過 2 年或以上沒有延續，將會被視作新註冊會籍。
4. 享有參與總會其業務/運動相關活動之權利。
5. 正式會員享有派代表出席總會與其業務/運動相關之執行委員會會議及提交意見之權利。
6. 享有租/借用總會名下與其業務/運動相關之設施之權利。
7. 正式會員可享有出席潛總週年會員大會投票之權利
8. 所有團體會員可收取潛總與其業務/運動相關之資訊，會議記錄等。
9. 所有團體會員享有優先贊助總會活動之權利，贊助批准後，可於活動舉辦的場合適當地張掛公司標誌。
10. 所有團體會員必需約束其屬下個人會員，除非經本會批准及授權，否則不可以使用總會或以「中國香港」名義參與任何海外活動賽事。違者本會會立即取消其屬會資格。本會亦不接受有任何曾違反以上規則的團體入會。

III 《Rights, Responsibilities & Favorable Terms》

1. Agree to be bound by the rules and regulations and decisions of HKCUA.
2. All members must renew their memberships not later than 31st April to June; otherwise, all benefits given will be suspended after 1st April every next year.
3. Club will be deemed as the new registered if do not renew the club over 2 years or above.
4. Club has right to participate activities held by HKCUA that related to its' business nature.
5. Club has Right to authorize representatives to sit the board directors' meetings that related to their business nature only.
6. Club has Right to lend/to let the facilities under the name of HKCUA that related to their business nature only.
7. Club has Right to attend Annual General Meeting and right to vote.
8. Club will receive most updated information and minutes from HKCUA that related to their business nature.
9. Right to prior sponsor HKCUA's activities, hang company's logo at an appropriate location during the sponsored activities.
10. All club member must restrict their individual members under their jurisdiction. Without approval and authorization by HKCUA, members should never participate in any activities or competitions under the name of HKCUA or "Hong Kong, China." Violators will have their membership status immediately revoked. HKCUA will not accept any group/team/club that has violated the above rules to join us as member .
